

The ICFAI Foundation for Higher Education (IFHE) was established in the year 2008 as a Deemed-to-be University under Section 3 of the UGC Act, 1956. It has five faculties consisting of Management (ICFAI Business School), Science & Technology (IcfaiTech), Law (ICFAI Law School), ICFAI School of Architecture and ICFAI School of Social Sciences.

The University is accredited by the National Assessment and Accreditation Council (NAAC) with 'A++' grade with a CGPA of 3.59 out of 4 points in 2022. The University has also been graded as 'Category 1 Autonomous Institution' by UGC. This puts the University among the best in the country.

ICFAI Business School (IBS) is one of the largest in Asia and has been consistently ranked among the leading business schools in India. IBS is one of the first three from South Asia to get the SAQS accreditation from AMDISA (Association of Management Development Institutions of South Asia). IBS has also received 'Excellent' rating from CRISIL and ICRA. The Association to Advance Collegiate Schools of Business (AACSB) with headquarters at Tampa, Florida has cleared two Initial Self Evaluation Reports. IBS is recipient of the prestigious AACSB accreditation.

The Faculty of Management (ICFAI Business School) offers BBA, MBA, Executive MBA and PhD programs (Full-Time and Part-Time). The Faculty of Science & Technology (IcfaiTech) offers B Tech, B.Sc (Physics & Maths), M Tech and PhD programs. The Faculty of Law (ICFAI Law School) offers five-year BBA-LLB (Hons) and BA-LLB (Hons) programs, LLM program and a PhD program and seven certificate programs in Law. ICFAI School of Architecture offers B.Arch. program. ICFAI School of Social Sciences offers BA (Economics) and MA (Economics) programs.

To make management education more application oriented, the University has a Case Research Center (CRC) which has developed a large number of cases. We are a member of UK-based "The Case Centre", which is the largest case repository in the world. In The Case Centre's Global Top 50 Bestselling Case Authors Ranking - 2022/23, ICFAI Business School is ranked Second with Seven authors making it to the coveted list, just below Harvard Business School with Eight authors. Our cases are taught in no fewer than 870 B schools across 75 countries of which more than hundred are AACSB accredited institutions across the world including INSEAD, Columbia University, University of California-Berkeley, Johns Hopkins University, London Business School, ISB, Oxford University and Cambridge University.

More than hundred cases have been published as part of standard international textbooks and case volumes. The cases developed here have won a number of international prizes.

The students come from all over India and girls form about 40 per cent of the student population. There is no management/ NRI quota.

N J Yasaswy (1950-2011)

Mr. N. J. Yasaswy (1950-2011), founder of the ICFAI Group of educational institutions and a pioneer in promoting higher education in the private sector had a brilliant academic career: B.Com (Andhra University 1969 – First Rank), CA Inter (May 1971 – first Rank), CA Final (May 1973 – First Rank), ICWA Inter (July 1970 – First Rank) and ICWA Final (July 1972 – First Rank). He was the recipient of the Basu Foundation Award for the Best Student of the Year from both – The Institute of Cost and Works Accountants of India (in 1972) and The Institute of Chartered Accountants of India (in 1973).

During 1974-1980, Mr. Yasaswy was associated with the Administrative Staff College of India as a Faculty Member. In 1981, he started his consultancy firm, Yasaswy Management Associates (P) Limited. Hyderabad.

Mr. Yasaswy was appointed by the Government of Andhra Pradesh as Chairman, Andhra Pradesh State Trading Corporation (1985–88), and Vice-Chairman, Public Enterprises Management Board (1986–88). He was a visiting faculty member at the Indian Institute of Management Ahmedabad (1986-88) and was nominated as a Member on the SEBI Committee on Accounting Standards. He was a member of the Board of Directors of the Association of Certified International Investment Analysts (ACIIA), Switzerland. He authored several books on finance and investments.

Mr. Yasaswy set up the ICFAI group as a single institute in 1985 without governmental sops or institutional funding, in an era where government support was the norm. He chose to spend all his energy on the fledgling institution which over the years grew to become a monument to what ambition can deliver. He was instrumental in building several business schools and eleven universities in the developing states of India, particularly in the North-East region. The ICFAI Foundation for Higher Education in Hyderabad occupies pride of place among the several institutions he started and was close to his heart. He stood for professional management, excellence in the quality of education offered in the ICFAI institutions, and absolute discipline.

He was charismatic, a great teacher, an institution builder, a visionary and a genius who was years ahead of his time. His vision will continue to guide ICFAI forever.

Speaker Profile



Prof. **Janat Shah** is the founding director of IIM Udaipur. Under his leadership, IIM Udaipur has become the fastest growing management school in the country. IIMU arrived on the global education stage by getting accreditation from the AACSB in merely eight years of its establishment. With this achievement, IIM Udaipur has joined the elite group of 5 percent of the world's B-schools to be accredited by AACSB. For consecutive two years, IIMU has been listed on the QS and FT Masters in

Management (MIM) Rankings. IIMU is the youngest B-school in the world on both these rankings. IIMU is consistently counted among the top 5 institutes in India for research in management according to the methodology used by UT Dallas.

After graduating as a mechanical engineer from the Indian Institute of Technology, Mumbai, he worked with industry for about five years. He has obtained his Fellow in Management from the Indian Institute of Management Ahmedabad.

Before joining IIM Udaipur, Prof. Janat Shah has been with IIM Bangalore as a faculty of operations management for almost 20 years. Recipient of several teaching awards, he was also voted as the best teacher by MBA class of 1999. He was the principal researcher of the team which has won IBM faculty awards three times (2005, 2006 and 2008) for their work on human resource supply chain management.

Author of 'Supply Chain Management: Text and cases', Prof. Shah is a leading authority in the fields of Supply Chain Management and Operations Strategy. His book has been used in MBA and executive MBA courses at IIM Bangalore as well as at numerous other business schools throughout India. He has also published extensively in national and international journals.

Prof. Shah has consulted with a number of companies, including Aditya Birla Group, Bharti Airtel, IBM, Infosys Ltd., Mahindra & Mahindra, Tata Motors and Tata Teleservices. He has also helped companies design and develop decision-support systems for supply chain management.

Janat Shah has been the Chairperson of the Post Graduate Programme, coordinator of the Management Programme for Technologists and Chairperson Supply Chain Management center at IIM Bangalore. He was a Visiting Scholar at the Sloan School of Management, MIT. He was also a visiting faculty for a term with The Logistic Institute at National University, Singapore. He was the President of Society of Operations Management India from 2008 to 2010. He currently holds a position of Special professor at Nottingham University.

He has also been associated with Seva Mandir as a President (non-executive role) from September 2018. The Non-Profit Organization works on the community development in and around Udaipur, Rajasthan..
